CROSSRAIL GENERAL VESTING DECLARATION No. 45

This **GENERAL VESTING DECLARATION** is made the 12 JANUARY 2012 by Transport for London.

WHEREAS

- (1) Transport for London is authorised by order of the Secretary of State for Transport under section 51 of the Crossrail Act 2008 ("the Crossrail Act") to exercise powers under section 6 of the Crossrail Act to acquire compulsorily:-
 - (a) so much of the land shown on the deposited plans within the limits of deviation for the works specified in Schedule 1 to the Crossrail Act as may be required for or in connection with the works authorised by the Crossrail Act or otherwise for or in connection with Crossrail, and
 - (b) so much of the land shown within the limits of land to be acquired or used as may be so required.
- (2) Paragraph 4 of Part 2 of Schedule 6 to the Crossrail Act provides that the Compulsory Purchase (Vesting Declarations) Act 1981 ("the 1981 Act") shall apply as if the Crossrail Act were a compulsory purchase order and paragraph 5 of Part 2 of Schedule 6 to the Crossrail Act provides that the 1981 Act shall have effect subject to modifications.
- (3) Notice pursuant to section 3(1) of the 1981 Act as modified given on 26 October 2011 before the service of any notice to treat in respect of any of the land described in the Schedule hereto included the particulars specified in section 3(3) of the 1981 Act.
- (4) The notice referred to in (3) above did not specify any period longer than two months beginning with the date of its first publication as the period before the end of which this general vesting declaration could not be executed.

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on it by section 4 of the 1981 Act, Transport for London hereby declares:-

- 1. The land described in the Schedule hereto (being part of the land authorised to be acquired by the Crossrail Act) and more particularly delineated on the plan annexed hereto, together with the right to enter upon and take possession of the land shall vest in Transport for London as from the end of the period of 28 days from the date on which the service of notices required by section 6 of the 1981 Act is completed.
- 2. For the purposes of section 2(2) of the 1981 Act, the specified period in relation to the land comprised in this declaration is one year and one day.
