GENERAL PERFORMANCE NOTICE

This General Performance Notice is issued by Docklands Light Railway Limited ("DLRL") pursuant to Schedule 13 (*Enforcement Regime*) of the Franchise Agreement dated 17 July 2014 (the "**Franchise Agreement**") between DLRL and Keolis Amey Docklands Limited (the "**Franchisee**") and requires the Franchisee to propose a Remedial Plan to remedy the failure or contravention set out in this Performance Notice.

DLR is entitled to serve a **General Performance Notice** on the Franchisee if the Franchisee breaches any obligation in the Franchise Agreement which (in DLRL's absolute discretion) has or may have consequences to DLRL or the Franchisee which are not immaterial

Schedule 19 Paragraph 20 of the Franchise Agreement requires the Franchisee to have attained the standard of Bronze Accreditation (or higher) under the Fleet Operator Recognition Scheme (FORS) or the equivalent within the Alternative Scheme within 90 days of the Franchise Commencement Date. This period ended on 7 March 2015. We reviewed the progress to date with your team at a meeting on 9 March and while we were assured that work is in progress it is apparent that the required level of Accreditation and associated driver training has not been achieved. There is also further work required to ensure that your sub-contractors comply with the requirements.

ASSET MANAGEMENT PERFORMANCE NOTICE

This Asset Management Performance Notice is issued by Docklands Light Railway Limited ("DLRL") pursuant to Schedule 13 (*Enforcement Regime*) of the Franchise Agreement dated 17 July 2014 (the "**Franchise Agreement**") between DLRL and Keolis Amey Docklands Limited (the "**Franchisee**").

DLRL is entitled to serve an **Asset Management Performance Notice** on the Franchisee when any of the circumstances listed in paragraph 3.3 of Schedule 13 arise in any Fee Period provided a warning of 30 days' duration has been issued to allow the Franchisee to rectify such failure.

A prior warning of the failure described in this Performance Notice was issued to the Franchisee on 13 February 2015 and such failure was not rectified within the required 30 day period, namely the failure to carry out maintenance activities outlined in Part 5 of Schedule 4 of the Franchise Agreement with respect to the Electrical & Mechanical, High Voltage and Premises asset groups during Railway Period 11.

Paragraph 3.5 of Schedule 13 of the Franchise Agreement DLRL requires the Franchisee to propose to DLRL for acceptance a reasonable and appropriate **Remedial Plan** to remedy the failure or contravention set out in this Performance Notice. However, on this occasion and without prejudice to its

This Operations Performance Notice is issued by Docklands Light Railway Limited ("DLRL") pursuant to Schedule 13 (*Enforcement Regime*) of the Franchise Agreement dated 17th July 2014 (the "**Franchise Agreement**") between DLRL and KeolisAmey Docklands Limited (the "**Franchisee**").

DLRL is entitled to serve an '**Operations Performance Notice**' on the Franchisee when any of the circumstances listed in paragraph 3.1 of Schedule 13 arise, specifically Paragraph 3.1 (c) provides the right for DLRL to issue a Performance notice if:

(c) Departures Actual for a Peak Period on any three Service Days within a Fee Period is less than 92%

The relevant dates and incidents which impacted on peak period performance were:

- Monday 8th February (evening peak: 70.36% Departures)
- Thursday 18th February (evening peak: 91.97% Departures)
- Thursday 25th February (morning peak: 89.66% Departures)
- Friday 26th February (morning peak: 90.76% and evening peak: 78.39%)



- (iii) 1st March 2018 – Departures Actual – 94.11%


The proposed Remedial Plan must specify, in reasonable detail:-
