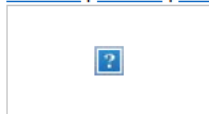

Sounds interesting, I'm sure we'd be keen to discuss that opportunity further with you. I've sounded out a few people internally including our team who do the strategic cycling analysis work, and will come back to you when I hear back. But yes I believe it's feasibly possible that we could take on scoping work like this – would also need agreement from the boroughs involved, Ealing & H&F, as Highway Authorities if it came to that (with OPDC as planning authority)

We did have a commercial cost estimate produced for CFR23 in outcome definition stage, which was a fairly crude estimate based on the length of route and expected type of cycle infrastructure, e.g. segregated throughout. So I suppose a figure could be produced for Old Oak Common Lane depending on initial assessments of things like cycling demand, traffic flows and what types of infrastructure would be suitable for those roads, to connect to the new station and wider existing/proposed cycle routes in the network. Thanks, and hope you're also keeping well – strange times indeed!
