Transport for London in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984^a, and of all other enabling powers, hereby makes the following Order—

1. Commencement and citation

This Order may be cited as The GLA Roads and GLA Side Roads (Southwark) Red Route Consolidation Traffic Order 2007 Variation Order 2016, and shall come into force on 12th September 2016.

2. Variations

The GLA Roads and GLA Side Roads (Southwark) Red Route Consolidation Traffic Order 2007^b is varied by the following provisions of this Order.

- 1 In Schedule 2B Main Road item 1 is substituted as follows:
 - 1. A100 (TOWER BRIDGE ROAD), the north-west side from a point 1.2 metres south-west of the extended common boundary of Nos. 77 and 79 Tower Bridge Road to a point 12 metres north-eastwards.
 - No Stopping Mon-Sat 7am 7pm Except 10am-4pm parking 1 hour No return within 2 hours
- 2 In Schedule 2B Main Road item 10 is deleted.
- 3 In Schedule 2B Main Road item 40 is substituted as follows:
 - 40. A100 (TOWER BRIDGE ROAD), the north-west side from the extended common boundary of Nos. 29 and 31 Tower Bridge Road to a point 12 meters north-eastwards.
 - No Stopping Mon-Sat 7am 7pm Except 10am-4pm parking 1 hour No return within 2 hours
- 4 In Schedule 2B the following Main Road item is added after item 48 as follows:
 - 49. A100 (TOWER BRIDGE ROAD), the south-east side From the extended common boundary of Nos. 46-48 Tower Bridge Road to a point 10 metres north-eastwards.
 - No Stopping Mon-Sat 7am 7pm Except 10am-4pm parking 1 hour No return within 2 hours

 - 1. (UNNAMED SERVICE ROAD FRONTING NOS. 108 TO 114 TOWER BRIDGE ROAD), the south-east side from a point .7 metres north-east of the extended common boundary of Nos. 104 to 108 and No. 110 Tower Bridge Road for a distance of 6 metres in a south-westerly direction.

- In Schedule 3A Main Road item 7 is substituted as follows:
 7. A100 (TOWER BRIDGE ROAD), the north-west side from a point 30 metres northeast of the extended common boundary of Nos. 29-31 Tower Bridge Road to a point 18 metres north-eastwards.
 No Stopping Mon-Sat 7am 7pm Except 10am-4pm loading max 20 mins and disabled persons' vehicles max 3 hours
- In Schedule 3A Main Road item 11 is substituted as follows:
 11. A100 (TOWER BRIDGE ROAD), the south-east side from a point 13 metres northeast of the extended common boundary of Nos. 74 and 76 Tower Bridge Road for a distance of 12 metres in a north-easterly direction No Stopping Mon-Sat 7am 7pm Except 10am-4pm loading max 20 mins and disabled persons' vehicles max 3 hours
- 15 In Schedule 3A Main Road item 12 is deleted
- 16 In Schedule 3A Main Road item 13 is deleted
- 17 In Schedule 3A Main Road item 15 is deleted

 59. A2 (OLD KENT ROAD), the north-west side from the extended common boundary of No. 181 and No. 183 Old Kent Road to a point 8.5 metres southeast of the extended common boundary of No. 199 and Nos. 201 to 203 Old Kent Road.

 75. A2 (OLD KENT ROAD), the south-west side from a point 2 metres south-east of the extended north-western building line of No. 288 Old Kent Road to a point 4.5 metres south-west of the extended north-eastern building line of No. 306 Old Kent Road.

 - 54. ASYLUM ROAD, the west side between a point 3.6 metres south of the extended northern boundary line of No. 139 Queens Road and the northern kerb-line of Queens Road.

 - 28. MARSHALSEA ROAD, the south-east side from a point 9.6 metres north-west of the extended south-eastern building line of No. 3 Marshalsea Road to a point 5.7 metres south-east of the extended north-western building line of No. 7 Marshalsea Road.
