

MD SURFACE TRANSPORT WRITTEN CONSENT

Delegation to Officer

This is a Written Consent from the MD Surface Transport pursuant to TfL Standing Order 127.

TfL Standing Order 125 delegates from the Board to each Managing Director any TfL functions in respect of matters for which that MD has responsibility:

- (a) across the TfL Group;
- (b) in a managerial position; and/or
- (c) in a professional position;

except for functions reserved to the Board or delegated to other bodies or postholders by Standing Orders or otherwise.

Standing Order 127 delegates from the Board to each Officer (other than the Commissioner, a Managing Director or an Officer specified in standing order 124) the discharge of any functions of TfL in respect of matters for which that Officer has responsibility:

- (a) across the TfL Group
- (b) in a managerial position; and/or
- (c) in a professional position;

except for functions reserved to the Board or delegated to other bodies or postholders by Standing Orders or otherwise.

The delegation in Standing Order 127 is subject to two conditions set out in SO 128:-

- (a) the MD to whom the Officer reports has also been delegated authority in relation to that matter (this is satisfied by the delegation in SO 124); and
- (b) the Officer has obtained the written consent of that MD or the Commissioner to the exercise of that delegated authority.

This Written Consent is therefore given to satisfy the condition in SO 128(b).
