


## MD SURFACE TRANSPORT WRITTEN CONSENT

TfL Standing Order 130 provides that officers responsible to the MD Surface Transport can perform functions delegated to him where a written consent is provided. This is such a written consent.

Functions to which this consent relates are listed in Annex 1; officer roles to which this consent relates are listed in Annex 2 and include interim appointments.

A delegated function must fall within an officer's area of responsibility and appropriate arrangements must be in place for supervision, management and control in relation to the exercise of that function. The exercise of delegated functions must also be compliant with the law, the other provisions of TfL's Standing Orders and any applicable policy and procedure.

This written consent replaces any consent previously issued within the Surface Transport Directorate and applies from the date signed.
