Dear Inspector Billany, Met Police, Kings Cross

Below is the case law in relation to cross border hiring. To meet the triple licensing criteria, as you know, bookings must be with the same vehicle, driver & operator, however if a booking is taken with the Uber London operator in Manchester the vehicle has to be dispatched from the London geographical area, see section 8 <http://www.licensingresource.co.uk/sites/default/files/2599.pdf> for a TfL vehicle & driver "waiting" to be booked in Manchester is illegal

It is clear that the Manchester licensing authority cannot carryout enforcement of TfL vehicles or drivers working in Manchester, so they work largely unchecked

I now remind you of the disgusting Rotherham child sexual exploitation case where minicab drivers operated out of sight, please tell me what the difference is, and have the Police Service and Government 'learnt the lessons' of that case? - I think not, therefore this needs to be addressed, and certainly doesn't need the police service sweeping this under the carpet

Further to this, Silka Kennedy Todd, [REDACTED] & [REDACTED] refuse to answer the question : **Who accepts the payment for the Uber booking in London** even though Silka has stated on the 21 Sept 2016 at 11:18 am

"In accepting the booking and taking the payment , there is in our view, what amounts to a contractual agreement between the operator and the passenger"

We know full well that the Dutch entity of Uber BV take the payment, therefore Silka & TfL has almost certainly revealed that UBER BV is the operator who are unlicensed

The implications are huge

- 1 Are the passengers fully insured riding in a car where the booking method is unlicensed?
- 2 There are VAT implications as TfL have licensed an business that is evading VAT (VAT is paid in the country the services are provided) I'll remind you, it's a criminal offence for TfL not to carry out ante money laundering due diligence compliance when licencing a company to carry out financial transactions

Therefore the Silka & TfL need start answering questions as they are bound to do so under the Nolan Principles, or I'm lodging a compliant (with the Met Police) of perverting the course of justice

We clearly need to have some dialogue, however, I will not be ignored on such important public safety issues - therefore, I'm giving you a further 7 days before I make a complaint to the IPPC

I hope that we can address this amicably without the need to make a complaint

Dear Mr Billany

I am very concerned that Uber London (the TfL London licensed operator) are carrying out bookings illegally across the country, as you are aware, the deregulation act allows sub-contracting between operators inside and outside of London, however there is still some important *case law* within the sub-contracting process that is not being met by Uber.

If Uber Britannia (the holder of Uber operators licence for Manchester) sub contract the booking to UberLondon (the TfL licensed operator) who have a TfL licensed driver and vehicle unbooked and waiting in the Manchester area and the booking is carried out, even though the triple licensing requirement is fulfilled, the booking would be illegal as the TfL licensed vehicle has not been dispatched from the geographical area where the vehicle is licensed - this being London.

The only way a London registered driver & vehicle can pick up in Manchester (subject to meeting the triple licensing criteria) is if the driver & vehicle physically drove from London to Manchester to pick the passenger up, hence the rationale for Uber being allowed to 'pick up' passengers in Manchester as they hold a Manchester operators licence and can sub contract the booking from Uber London to Uber Britannia, but they can only 'pick up' passengers with Manchester registered vehicles and drivers - this fulfills the triple licensing criteria - anything else is illegal.

This criteria is set out in case law and shown in the Blue Line Taxis(NEWCASTLE) Ltd v The Council Of The City Of Newcastle-Upon-Tyne case.

Part 8. The operation is geographically fixed in the operator's licensing area: that area must be where the operator's premises are located, bookings made and from which **vehicles are dispatched**.

Should you disagree with the above, the question I ask is: Why would any operator obtain more than one operators licence nationwide? As they wouldn't need more than one.

What the Blue Line Taxis V City of Newcastle-Upon-Tyne case does, is protect the ability for each individual licensing authority to enforce regulation within their own area.

Government hasn't removed the ability for local authorities to enforce regulation in their own area and the deregulation act certainly doesn't do this, therefore why are TfL licensed vehicles & drivers waiting to be booked in Manchester and other parts of the country?

This fiasco has only been allowed to happen because TfL are woefully inadequate and out of touch with policy and law.

I look forward to your reply.

Subject: Another Death? Are the police force covering up TfL malfeasance?

Dear Mr Billany.

I am writing to You and the met police formally.

After what looks like another death on our roads, when are the police going to start taking the allegation of malfeasance at TfL seriously?

Inexperienced private hire drivers don't have a basic knowledge of the road infrastructure in the area they are working and those who accept bookings while driving are clearly a danger to the public.

TfL are issuing private hire licences like confetti with no regard for policy or public safety, In doing so gifting private hire drivers (predominately drivers working for Uber) the ability to accept bookings in any part of the country - I allege that acceptance of bookings using the Uber platform is illegal (*as explained in the attachment below*) therefore, should not have been licensed by TfL.

There **is** policy in place at TfL to protect the public - this is policy that has been widely ignored.

Therefore, I'm alleging malfeasance at TfL as the current crop of death's caused by private hire drivers should have been averted if TfL were competent.

There is no excuse for the loss of life, ignorance of the law is no excuse for the public, police or

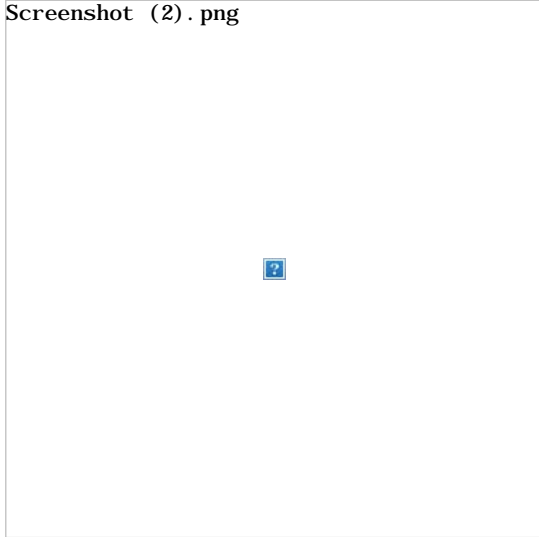
civil servants, if it is found that civil servants have ignored due process they should be subject to the laws that we are all bound by.

This policy is set out initially in two pieces of documentation.

The first is, Private Hire Licensing Guidance Notes, Part 4 explains how operators have to adhere to **Health & Safety law** prior to granting an operators licence.

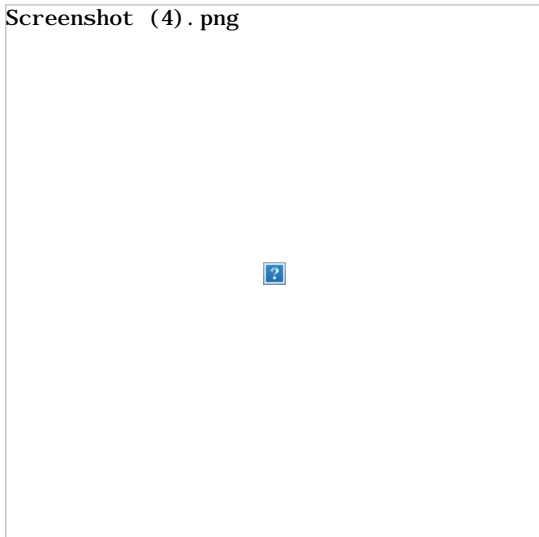
The second policy document designed to protect the public is - Guidelines for Aftermarket Electronic Devices in Private Hire Vehicles.

This TfL policy document needs to be signed by ALL operators and drivers to ensure that **the electronic device will not interfere with, or adversely affect the performance of the driver.**

According to a recent FOIA, TfL have neglected this duty, and as a result no driver or operator has signed this public safety policy document.

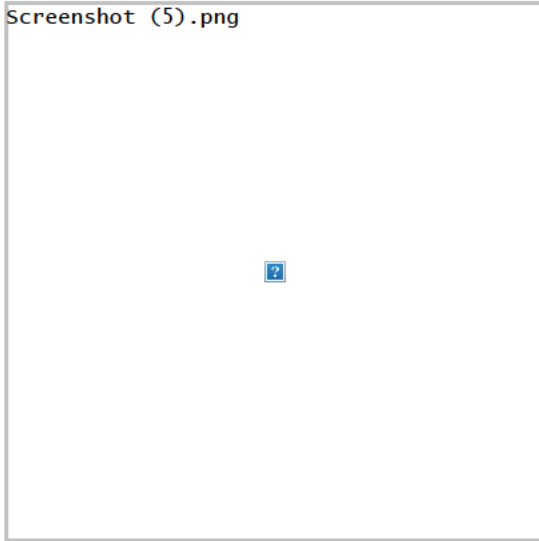

The granting of a private hire operators licence by TfL **MUST** adhere to due diligence as set out in law, this has clearly been breached. Part 4 of the operators guidelines claims:

Health and Safety: If required, applicants must be able to show that they are complying with any requirements applicable to the public. e.g environmental health.

These Health and Safety & Road Safety guidelines are set out in the HSE's managing work related road safety directive, shown here....<http://www.hse.gov.uk/pubns/indg382.pdf>

It's clear that risk assessment's are **required in law** to be carried out by TfL prior to the granting of any licences.

Following a recent FOIA, It has been confirmed that TfL **have not** carried out any risk assessments in relation to Uber and it's driver booking acceptance process.

As an addition to the law for personal driving, driving for work related purpose is set out in tighter legislation, therefore subject to more stringent risk analysis and public safety protocols (as set out in the policy documents above).

There are questions TfL have never asked of Uber:

Does the electronic device for accepting bookings while driving adversely affect the performance of the private hire driver?

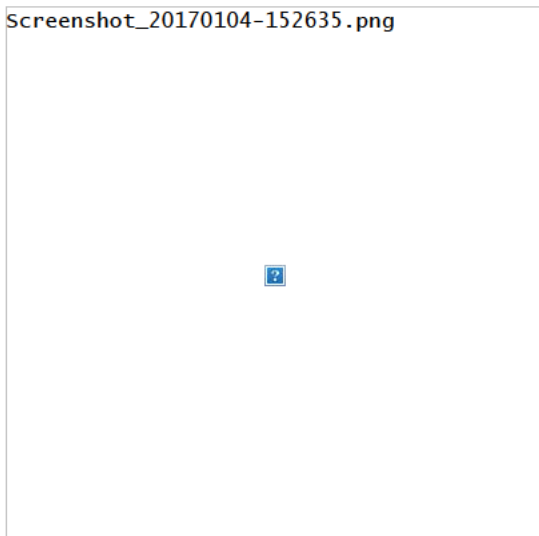
- As per the guidelines for the use of aftermarket devices in private hire vehicles.

Does the Uber driver app (or any other booking acceptance app) comply with the HSE's work related road safety directive and what is required in law?

The question being; Is there a detrimental risk to the public in allowing inexperienced drivers without a knowledge of the area they are working to accept bookings while driving?

If the answer is yes, and there is a detrimental risk to the general public in licensing an operator to operate a booking system that 'honey-traps' drivers into accepting a booking while being distracted when driving, and TfL haven't carried out their due diligence as set out in law, then the allegation of malfeasance can be claimed if a death has occurred.

Further to this, the granting of the licence again raises significant questions of malfeasance. The screenshot below is a direct lift from the TfL website and clearly explains **'any app that puts a customer directly in touch with a driver without the booking being accepted first by the operator is illegal'**.

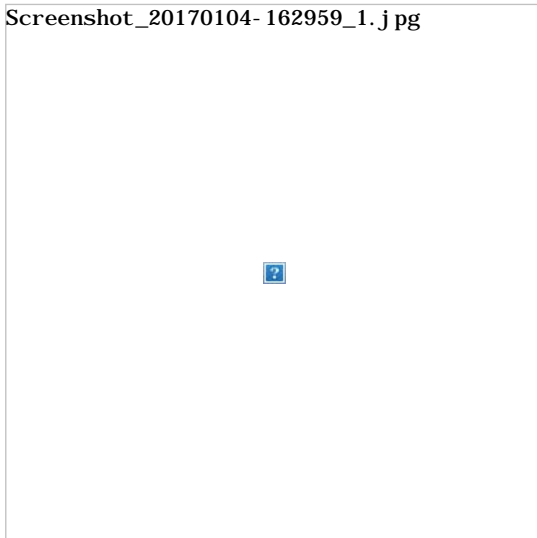

However, during the **City of Toronto V Uber Canada** case, Uber explained that their app is a generic app that operates by the same process worldwide.

As you will see from the extract, **the only person doing the accepting is the driver**, this clearly contradicts TfL's policy that **'any app that puts a customer directly in touch with a private hire driver without the booking being accepted first by the operator is illegal'**.

This booking process is backed up by the factual evidence submitted by Jo Bertram, Uber London's General Manager at the recent employment tribunal case.

This raises another issue, TfL's policy claims; **any app that puts a customer directly in touch with a private hire driver without the booking being accepted first by the operator is illegal'**.

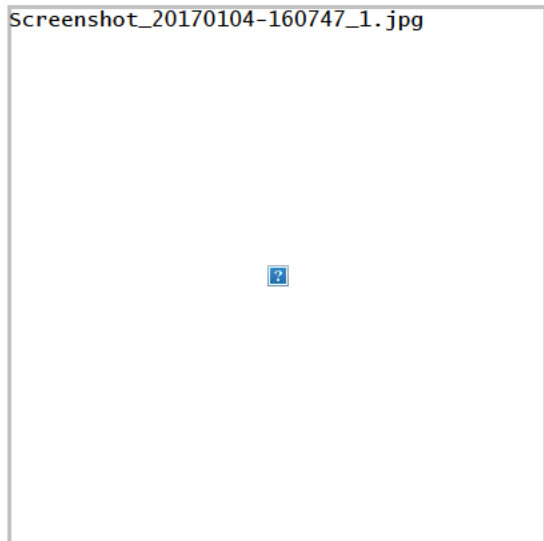
The only person doing the accepting is the driver.

then an allegation can be made that TfL haven't carried out their due diligence. Therefore, a claim of malfeasance be alleged, based on the fact that Uber London and private hire drivers working on the Uber Platform are operating illegally, a direct result of this being; drivers are accepting bookings directly from the customer while being distracted in the operation of a motor vehicle, culminating in the potential loss of life and risk to the public.

On numerous occasions I have requested to record these allegations formally with the police - all requests have fallen on deaf ears.

Should I be concerned that the funding your department receives from TfL adversely affects any impartiality?

Hi Both,

I've had a meeting with the Traffic Prosecutions team today to identify what they do with Taxi and Private Hire drivers who are reported for motoring offences by the wider MPS. It would seem that for 'routine' offences such as speeding, contravening red lights and using a mobile they are processed (either to court or via a FPN) but there is no onward disclosure to anyone.

Firstly, would you be interested in receiving this information and would it be of any use? Presuming you are, what process would work best for sending it through?

In terms of meetings to discuss ongoing cases and disclosures, absolutely yes from me, I will be the main rep for the unit (and MPS.) As it stands I wouldn't see a value to Met Intel having involvement in the process, I have concerns about the way things have been portrayed to you and from what I've seen some of the issues they have identified would never be disclosed as they simply aren't relevant (in one the venue for a sex assault is shown as the flat above a minicab office, they have flagged this as a failure by my team...)

Thanks for your reply.

As I have already explained, there were many messages in Twitters DM function about the Met's cab unit and TfL into what looks like a lack of impartiality or transparency.

The rational for putting your email on Twitter is because it's a business email address, and not a personal email address, a search of the Internet would certainly reveal that anyway.

I'm not sure that putting something into the public domain that's already there is that disappointing.

Secondly, as you're the police's liaison officer to TfL for the cab trade there is natural assumption you're the best placed contact for taxi drivers, as you have your finger on the pulse, so to speak.

Given Jamie Robert's (UCG) will be meeting with you at TfL next year under the Mayor's new engagement policy, I don't think it was unreasonable to tweet him your police email to touch base.

For several months now, I have been asking you to take a statement regarding an allegation of malfeasance at TfL in relation to the licencing of the Uber, specifically the booking process.

All evidence suggests that the booking is not being accepted via Uber London (the London operator) - contrary to the 1998 PH act. There is prima facie evidence that the bookings are being accepted illegally via Uber BV - a separate business entity based in Holland.

Should this be the case, Uber drivers would be carrying out the jobs illegally, subsequently any death or serious injury caused by these drivers should be placed under public scrutiny.

For this reason, I wish to put on record an allegation that TfL issued an illegal licence to Uber London Ltd and this being directly responsible for the deaths and serious accidents caused.

You have refused time after time to take a formal statement on this matter - this is a concern to the public, given the sheer weight of evidence - I was always under the illusion that if you suspect it - report it.

I'm also concerned as to the reason you're refusing to take a statement regarding this allegation.

The Mayors reply to Caroline Pidgeon's London assembly question 2016/4537 (attached) is explicit and claims that TfL funds the MPS cabs unit.

Could it be suggested there is an underlying lack of desire to take a statement or address the road deaths caused potentially by TfL's wrongdoing for fear of a TfL cut to the MPS budget should TfL be questioned?

I will ask Caroline Pidgeon if she would ask the Mayor if a member of the public suspects a government department of wrongdoing, should the police act in the interest of the wider public even if they are funded by that department?

As ever, I am happy to work with the police and fully support and respect the great work you do. Please feel free to review your comments as my door is always open and your offer of a coffee in the new year still stands.

I'm not going to get into an email discussion with [REDACTED] however to clarify there is no new legislation coming into force tomorrow, only new sentencing guidelines for the offence of using a mobile phone whilst driving, which doubles the punishment to a £200 fine and 6 penalty points.

As far as I am concerned the Plymouth Herald and what purports to be a lift from the Essex Police Facebook page (although the spelling is questionable and some of the advice is blatantly incorrect) are not binding on the Met Police and will not alter our approach to dealing with driving offences.

My view is that professional drivers should know both the laws of the road and the Highway Code and drive in accordance with both, what further guidance they need from TfL on the subject is unclear.

Can you please confirm TfL's position on the new road safety legislation coming into effect on the 1st March 2017.

Contained in this link is this paragraph:

Can you use your phone as a sat nav?

Yes – as long as you programme it before you start the car and set off and it's in a holder out of the 45-degree angle of the driver's view. You can't re-programme or touch it while in motion, the same rules apply for any sat nav.

It's clear, you can use your mobile phone if it's in a holder when the vehicle is stationary, but can't touch your phone once the vehicle is in motion even if it's in a holder.

Is TfL's policy different to this?

Alternatively, This post appeared on the Essex Police's facebook page (and confirmed with them by Alan McGrady).

Can you confirm if TfL agrees with this statement from them:

"If you work for Uber or alike, you can't touch the phone when the engine is on. So you can't accept work while you're on the move"

Alan McGrady has had this CONFIRMED by Essex Police:

****6 points and £200 fine for using a mobile whilst driving from 1st March 2017****

Advice to keep it simple:

- Keep your mobile in a cradle or glove box
- You can't touch the phone if it's in a cradle, even if you stop at lights and even if you're parked up with the engine on
- If you want to use the sat nav on a mobile or plug the charger in. You must set it up before keys are in the ignition and don't touch it once engine is on
- You can't scroll for tracks on your mobile while driving so have your playlist set up before entering the car
- If you work for Uber or alike, you can't touch the phone when the engine is on. So you can't accept work while you're on the move

- Mobile can only be used if you're parked up safely with engine off and keys out of ignition (Wireless keys - engine off)
- Death by dangerous driving is now life imprisonment, no longer 14 years
- You can use a mobile via built-in-car technology like Bluetooth. However, if you do have a collision, it can go against you.
- You can't use headphones
- You can't use loud speaker from your phone
- You can't move your phone while the engine is on
- If you call someone and they are driving, hang up
- If you are a passenger and the driver is using a phone, take it off them and tell them off
- If you are an employer and you force your staff to use a phone, it can result in imprisonment for you, large fines and your company being suspended from operation
- Rules apply to PDAs also

Note:

- 2.5 deaths a week due to a driver using a mobile phone
- No verbal warnings

We need some clear policy guidance from our regulator.

We've been seeing reference to (but no specific details for) an attack on a taxi driver allegedly by a PHV driver using an iron bar. We haven't sent this on because of the lack of information and because where we have been told about it, we've been told the PHV driver was arrested.

Letter from TaxiPoint Editor to TfL compliance: Uber abuse must stop.

May 12, 2017

On Wednesday evening a Taxi Driver was subjected to a vicious attack at South Kensington Taxi Rank by an Uber Driver after being asked to move off of the Taxi Rank so that he (the Taxi Driver) could perform his legitimate right to ply for hire on that rank. The driver was subjected to allegedly over THIRTY blows with an iron bar from the Uber driver. The Taxi Driver in question is lucky to be alive, the Uber driver has been arrested and charged. This act has prompted me to e-mail compliance to protest at their lack of presence and enforcement. A Taxi driver has the right to work without fear of violence or abuse in the same way as any other worker. TFL have a duty to protect the working rights of the Taxi industry. Here is the e-mail to compliance (and others) in full.

Dear Mr Rodgers & Dear Ms Kennedy-Todd,

I am e-mailing you to voice some serious concerns in relation to how the TFL Compliance teams are policing London's Taxi ranks.

I myself have had threats made against me including knife threats as I've tried to move PHVs off of Taxi Ranks so that I and my colleagues can lawfully ply our trade, Taxi drivers have been spat at and abused and attacked trying to do the same as myself and on Wednesday night an attack on a Taxi driver by an Uber driver armed with an iron bar in which the Uber driver wielded in excess of THIRTY blows led to the Uber driver being arrested and charged with GBH.

I am one of the representatives of Action For Cabbies, one of the editors of Taxipoint magazine and a working Taxi driver of 26 years service, I work afternoons and nights. I am extremely concerned at the lack of presence from your compliance teams, in fact I have not seen one single compliance officer operating at night for months, moreover I have not seen a single compliance officer move on nor ticket one single PHV on any rank. Admittedly you can only operate in areas where you have credible intelligence and I may not have been in areas where you may currently operate but quite frankly your endeavours are failing the Taxi industry.

There needs to be a root and branch re-evaluation as to how you are policing the PHV industry. Our job is to take people from one location to another, your job is to enforce the law surrounding both the Taxi and Private Hire industry. We are in the position that we are now having to police the ranks ourselves because of failures in reacting to credible intelligence supplied by ourselves. This is in turn leading to violence perpetrated against us. We are told to video, photograph and gather evidence.....yet despite the gathering of evidence there seems to be absolutely no enforcement on the ranks at night, you are conspicuous by your absence. You know exactly where the rank hotspots are, you have been informed many times via social media....and yet we are seeing little or no real action. I am seriously concerned that it will only be a matter of time before one of my colleagues is killed trying to do the job single handedly that you are charged to do as a unit. This is utterly unacceptable.

I would like to arrange a meeting with yourselves along with myself and several of my colleagues so as to devise a plan as to how we can move forward from this and assist you in carrying out your remit and helping you to be pro-active in protecting us from this ongoing, toxic and quite frankly dangerous situation. I appreciate that you deal with our trade organisations but I am afraid that this is no longer an acceptable course of action. I believe you need the input of drivers who are consistently at the sharp end of this problem on a night to night basis as we have a greater understanding of this issue.

Please note that I have also sent this e-mail to several other parties who may have an interest in this situation

I look forward to your swift response on this matter.

The Construction & Use Regulations 1986, as amended in 2003 state:

104. No person shall drive or cause or permit any other person to drive, a motor vehicle on a road if he is in such a position that he cannot have proper control of the vehicle or have a full view of the road and traffic ahead.

110.—(1) No person shall drive a motor vehicle on a road if he is using—

(a) a hand-held mobile telephone; or

(b) a hand-held device of a kind specified in paragraph (4).

(2) No person shall cause or permit any other person to drive a motor vehicle on a road while that other person is using—

(a) a hand-held mobile telephone; or

(b) a hand-held device of a kind specified in paragraph (4).

(3) No person shall supervise a holder of a provisional licence if the person supervising is using—

(a) a hand-held mobile telephone; or

(b) a hand-held device of a kind specified in paragraph (4),

at a time when the provisional licence holder is driving a motor vehicle on a road.

(4) A device referred to in paragraphs (1)(b), (2)(b) and (3)(b) is a device, other than a two-way radio, which performs an interactive communication function by transmitting and receiving data.

(5) [Exemptions for emergency use]

(6) For the purposes of this regulation—

(a) a mobile telephone or other device is to be treated as hand-held if it is, or must be, held at some point during the course of making or receiving a call or performing any other interactive communication function;

(b) a person supervises the holder of a provisional licence if he does so pursuant to a condition imposed on that licence holder prescribed under section 97(3)(a) of the Road Traffic Act 1988 (grant of provisional licence);

(c) "interactive communication function" includes the following:

(i) sending or receiving oral or written messages;

(ii) sending or receiving facsimile documents;

(iii) sending or receiving still or moving images; and

(iv) providing access to the internet.

In summary, the use of apps on a cradle-mounted phone is lawful under reg 110 but may, if done without common sense and good judgement, constitute an offence under reg 104 or s3 Road Traffic Act.

I've had the attached email from [REDACTED] on the same subject. I'm not sure where this advice has come from (in terms of what law they are basing it on.) Apart from the changes in penalty for using a handheld mobile whilst driving there is no new legislation and I haven't seen any new or revised guidance from the NPCC that would change anything that Simon or I have said before. I had a meeting with Gett yesterday on this topic and after seeing their app up close I have no concerns about it's use in principle. I discussed the issue of distracted driving and said the over-riding priority is concentrating on the road, if you are stationary and have to simply press an 'accept' button on a holstered device I can't see an offence (and you would be hard pushed to find a police officer who would report you for it, or a magistrate that would find you guilty.) I've copied in Simon as he may have more info on this given his expertise,

No. The phone must be secured in a holder out of the 45-degree angle of the driver's view. You can't touch it while driving.

Is it OK to answer a call while driving if your phone is on loudspeaker on your knee?

No. It's still classed as using your phone while driving whether it's in your hand or not.

Can you use your phone as a sat nav?

Yes – as long as you programme it before you start the car and set off and it's in a holder out of the 45-degree angle of the driver's view. You can't re-programme or touch it while in motion, the same rules apply for any sat nav.

(6) For the purposes of this regulation— (a) a mobile telephone or other device is to be treated as hand-held if it is, or must be, held at some point during the course of making or receiving a call or performing any other interactive communication function; (b) a person supervises the holder of a provisional licence if he does so pursuant to a condition imposed on that licence holder prescribed under section 97(3)(a) of the Road Traffic Act 1988 (grant of provisional licence);

(c) “interactive communication function” includes the following:

(i) sending or receiving oral or written messages; (ii) sending or receiving facsimile documents; (iii) sending or receiving still or moving images; and (iv) providing access to the internet.

In summary, the use of apps on a cradle-mounted phone is lawful under reg 110 but may, if done without common sense and good judgement, constitute an offence under reg 104 or s3 Road Traffic Act.

All,

I can confirm that there was an incident at this location, however the version of events portrayed on twitter and in the letter is very different to the version of events that at this time we can confirm actually happened.

A member of the public called police to a fight, which was attended by local police. On arrival and following initial investigation both parties were arrested for affray. The two people involved in this incident are both licensed drivers, one a phv and the other a taxi driver. Following interview they were released under investigation (new terminology owing to changes in bail legislation) pending further enquiries relating to independent witnesses and CCTV.

At the moment it is very much one work against the other, there are no significant injuries to speak of and we await more detailed medical evidence.

I will not be making a disclosure under CLPD at this stage, the OIC still has this option open to them, however I will not get involved in their investigation. We will keep a watch on the investigation once they return to the station and if either is charged or cautioned I will make a disclosure at that point.

A man by the name of Steve Kenton is involved in the reporting of this, he is keen to engage with TFL on issues affecting drivers (makes mention of a lot of unreported assaults by PHV (uber) drivers and Taxi drivers, some involving knives or drivers spitting at taxis. He was advised to encourage further reporting to police so we can get an accurate picture of what is happening and where – at this stage there is no real body of evidence to support his claims so drivers need to be pro-active in reporting to us.

We've been seeing reference to (but no specific details for) an attack on a taxi driver allegedly by a PHV driver using an iron bar. We haven't sent this on because of the lack of information and because where we have been told about it, we've been told the PHV driver was arrested.

Letter from TaxiPoint Editor to TfL compliance: Uber abuse must stop.

May 12, 2017

On Wednesday evening a Taxi Driver was subjected to a vicious attack at South Kensington Taxi Rank by an Uber Driver after being asked to move off of the Taxi Rank so that he (the Taxi Driver) could perform his legitimate right to ply for hire on that rank. The driver was subjected to allegedly over THIRTY blows with an iron bar from the Uber driver. The Taxi Driver in question is lucky to be alive, the Uber driver has been arrested and charged. This act has prompted me to e-mail compliance to protest at their lack of presence and enforcement. A Taxi driver has the right to work without fear of violence or abuse in the same way as any other worker. TFL have a duty to protect the working rights of the Taxi industry. Here is the e-mail to compliance (and others) in full.

Dear Mr Rodgers & Dear Ms Kennedy-Todd,

I am e-mailing you to voice some serious concerns in relation to how the TFL Compliance teams are policing London's Taxi ranks.

I myself have had threats made against me including knife threats as I've tried to move PHVs off of Taxi Ranks so that I and my colleagues can lawfully ply our trade, Taxi drivers have been spat at and abused and attacked trying to do the same as myself and on Wednesday night an attack on a Taxi driver by an Uber driver armed with an iron bar in which the Uber driver wielded in excess of THIRTY blows led to the Uber driver being arrested and charged with GBH.

I am one of the representatives of Action For Cabbies, one of the editors of Taxipoint magazine and a working Taxi driver of 26 years service, I work afternoons and nights. I am extremely concerned at the lack of presence from your compliance teams, in fact I have not seen one single compliance officer operating at night for months, moreover I have not seen a single compliance officer move on nor ticket one single PHV on any rank. Admittedly you can only operate in areas where you have credible intelligence and I may not have been in areas where you may currently operate but quite frankly your endeavours are failing the Taxi industry.

There needs to be a root and branch re-evaluation as to how you are policing the PHV industry. Our job is to take people from one location to another, your job is to enforce the law surrounding both the Taxi and Private Hire industry. We are in the position that we are now having to police the ranks ourselves because of failures in reacting to credible intelligence supplied by ourselves. This is in turn leading to violence perpetrated against us. We are told to video, photograph and gather evidence.....yet despite the gathering of evidence there seems to be absolutely no enforcement on the ranks at night, you are conspicuous by your absence. You know exactly where the rank hotspots are, you have been informed many times via social media....and yet we are seeing little or no real action. I am seriously concerned that it will only be a matter of time before one of my colleagues is killed trying to do the job single handedly that you are charged to do as a unit. This is utterly unacceptable.

I would like to arrange a meeting with yourselves along with myself and several of my colleagues so as to devise a plan as to how we can move forward from this and assist you in carrying out your remit and helping you to be pro-active in protecting us from this ongoing, toxic and quite frankly dangerous situation. I appreciate that you deal with our trade organisations but I am afraid that this is no longer an acceptable course of action. I believe you need the input of drivers who are consistently at the sharp end of this problem on a night to night basis as we have a greater understanding of this issue.

Please note that I have also sent this e-mail to several other parties who may have an interest in this situation

I look forward to your swift response on this matter.

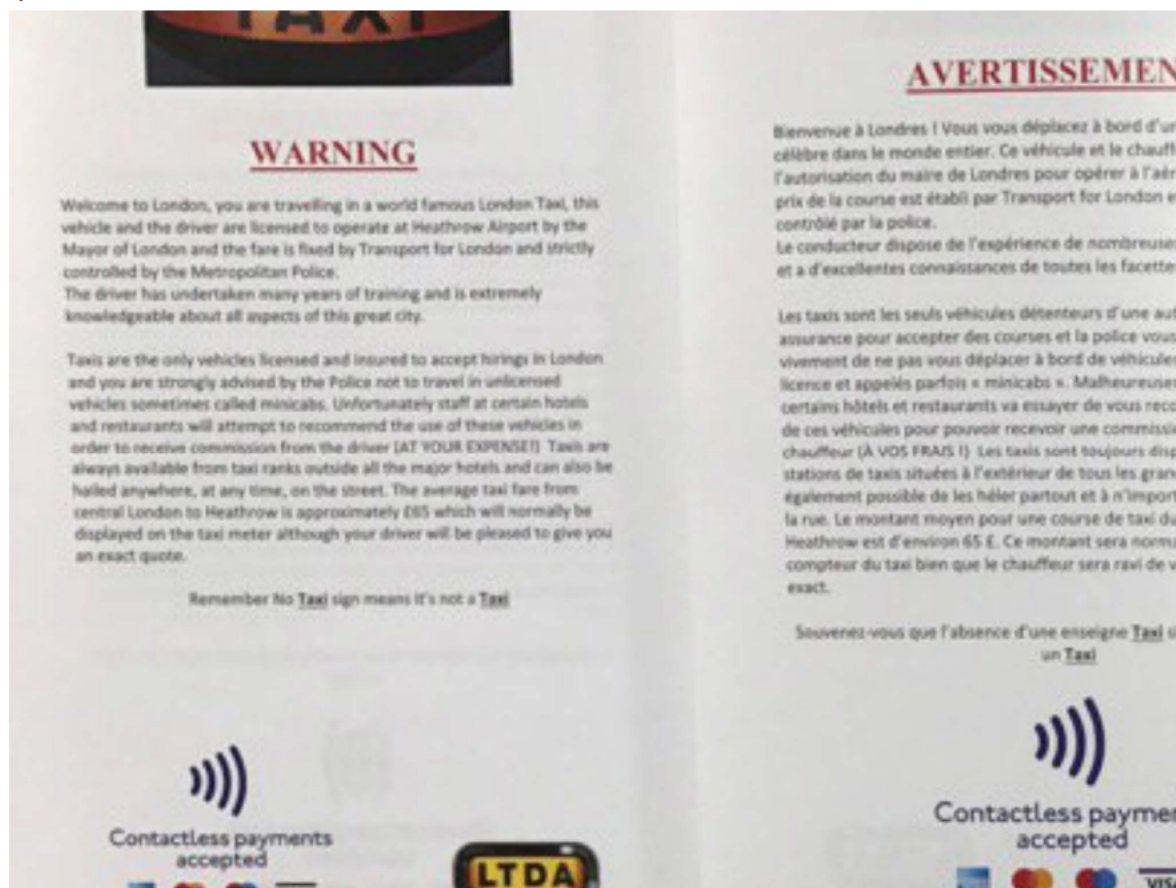

Following recent miscommunication and misunderstanding in the trade which we have all seen the fall out of on Twitter I have researched both the Uber and Gett booking systems to satisfy myself they do not cause a distraction. I do think there is a bigger bit of work to look at the correlation between collisions and PHVs, however with more drivers on the road, more passengers using apps and far more journeys taking place it would be logical to say there will be more collisions as an overall number, it's just if the overall % of PHV's involved in collisions has increased that there could be more work to be done on standards. I have liaised with both Geoffrey Riesel (Gett) and Jon Byrne (Uber) and have seen their systems in practice.

Neither requires more than a single press of a button to accept a job and once a job is accepted the app automatically routes the driver to the passenger without the need for any further data entry or interaction with the phone. Neither requires the reading of a text message as is mentioned in the misleading information supplied to other police forces to obtain their views.

As such the use of either app - if used appropriately - would constitute an offence.

Interestingly the Uber app will detect when the phone is being hand held and will prompt the driver to put it back in the cradle. Both Uber and Gett have provided recent advice to their drivers on the safe use of apps and also reminded them of the increased penalties for hand held phone use.

Following recent miscommunication and misunderstanding in the trade which we have all seen the fall out of on Twitter I have researched both the Uber and Gett booking systems to satisfy myself they do not cause a distraction. I do think there is a bigger bit of work to look at the correlation between collisions and PHVs, however with more drivers on the road, more passengers using apps and far more journeys taking place it would be logical to say there will be more collisions as an overall number, it's just if the overall % of PHV's involved in collisions has increased that there

could be more work to be done on standards.

I have liaised with both [REDACTED] (Gett) and [REDACTED] (Uber) and have seen their systems in practice.

Neither requires more than a single press of a button to accept a job and once a job is accepted the app automatically routes the driver to the passenger without the need for any further data entry or interaction with the phone. Neither requires the reading of a text message as is mentioned in the misleading information supplied to other police forces to obtain their views.

As such the use of either app - if used appropriately - would constitute an offence.

Interestingly the Uber app will detect when the phone is being hand held and will prompt the driver to put it back in the cradle. Both Uber and Gett have provided recent advice to their drivers on the safe use of apps and also reminded them of the increased penalties for hand held phone use.

As discussed, here is the information I have obtained regarding the case we were discussing earlier about the woman who was punched by a PHV driver.

As I stated, all info has come from her facebook account and we can't contact her directly as she hasn't contacted us before.

Silka (I've cc'ed you in as you are likely to get questions from the trade on this as its gained a lot of traction)

It appears that the incident occurred on Saturday 11th March

From reading the comments she does not have an Uber account herself, but a friend booked the Uber for her.

I've attached pictures that she used in the post that show her black eye.

It has been shared 748 times on Facebook and been tweeted about a great deal by our followers.

Below her transcript, I've included a link to the twitter campaign taken over by the SaveTaxis Account.

In the comments she claims that the driver's name is [REDACTED] and that he was driving a Black Prius.

Transcript of her Facebook Post

"PLEASE SHARE: Anybody that uses uber please dont ever use them again, especially if you are a girl/woman. i keep hearing all these stories about people getting attacked and never thought it would happen to me until me and baby were attacked on saturday.. myself & savannah have both been physically attacked by the driver over him refusing to help me carry something heavy to my house and me disputing as to why not. i dropped my house keys and he threw them in my 2 years olds face before punching me, trying to continue to hit me and force me back into his car leaving my daughter terrified on the pavement. He seemed very abrupt from the start of the journey telling me not to bother with my carseat and to hurry up. My daughter was crying in the car and I was told that if she didn't be quiet I would be physically removed and left stranded. When arriving I had no choice but to ask for help and was told to carry it all and if I drop her then good. He was angered by the fact I as woman asked him for help, as he said "you don't ask for help from man as woman you have no right, I tell you what I want and you must do" he also shouted that he is not a slave and that is my daughters dad role(bearing in mind my babydad is black African) which is not on. After allerting him of his racism he began to get progressively aggressive shouting to shut up I am a woman he will teach me my place. The keys were dropped as I backed away due to his aggressiveness and this is when he took the opportunity to attack my daughter.

Quite clearly he is racist and has a deep hatred towards women And should never be driving people in the first place!!

The police wouldnt arrest him or charge him with assault on myself and a minor unless i also got charged for assault and held in

a cell for hitting him ONCE whilst trying to protect my daughter from further attack as he progressed towards her once again and was released without any caution etc and allowed to drive on to pick up his next passenger. The police took no statement and failed to provide me with a CAD number but at the time i was so distressed that i didnt think of this. When going to police to retrieve this the next day the only thing logged in the system was that I was involved in a verbal altercation with no police assistance needed and no mention of our assaults especially towards my child!! The handling officers have been reported for the way they failed to deal with the situation and its seriousness. I was told I should be grateful of no arrest and its not worth all the agg and paperwork at the station, this is so unacceptable from people who are supposed to protect you especially your children!

This shit excuse of a company should be shut down, especially when the police allow them to continue with their job straight after what he did!! so please please dont pay these cunts a penny and stop using them"

Don't be blind to danger -- keep your windscreen clear

For many drivers, using smartphones and satnavs is part of the job. And while most know it's illegal to use handheld devices while driving, it's also important to understand the rules about where to keep them.

You shouldn't put or fix anything on your windscreen that will obscure your view of the road ahead. While that may seem like common sense, recent operations by the City of London Police have seen 11 tickets issued – including some to taxi and private hire drivers – for having mobiles and other devices restricting their vision.

If you place a cradled device on the area on your windscreen that is covered by your wipers (also known as the 'swept area') you are committing an offence. If you're prosecuted, you face a fine of up to £100 and three points on your licence.

A cluttered windscreen increases your likelihood of becoming distracted or not spotting potential dangers, such as pedestrians stepping into the road.

David Clark from the City of London Police says: 'The Highway Code is clear that a person must exercise proper control of their vehicle at all times and drivers should not let distractions reduce their awareness of the road.

'It's vital to have a clear and unobstructed view of the road at all times. Failing to do so puts other road users in danger, and could lead to collisions and serious injuries. If you use personal devices, make sure you fix them so that you still have a clear view of the road through your windscreen and use them only when it is safe to do so.'

In the UK, if you use a suction-mounted cradle that intrudes more than 4cm into the secondary (pink) wiper clearance zone, or more than 1cm into the primary (red) zone, you are committing a serious traffic offence. Your vehicle would not be considered roadworthy and would fail an MOT.
