Hi [REDACTED], [REDACTED] and co,

As I spoke about with [REDACTED] earlier, now that initial funding has been allocated we're looking to get a better idea of programme delivery across the LSP cycling workstream. As such, we need to include key date forecasts in the LSP trackers that are presented to TfL Directors, Will Norman, the DfT, etc. Could you therefore provide the latest estimates (to nearest week) for:

- a. When we might receive initial designs for review*; (only applicable for Castelnau and Hampton Court Road)
- b. Expected construction start date**; and
- c. Construction end date**.

* only applicable for Castelnau and Hampton Court Road schemes (assuming Kew Rd design has not changed since bid submission)

** assuming designs are approved following review in (a) and the release of full scheme funding

No problem if the delivery programme is less defined at this point, but it would be good to get a sense of rough dates as soon as possible.

At the same time, could you also provide a weekly spend forecast for (i) the initial design funding (for Hampton Court Road and Castelnau) and (ii) the full construction programme (for all three schemes)? Again appreciate this might be more difficult to estimate given the pace and uncertainty of these temporary schemes, but any clarity from yourselves would help strengthen our LSP-wide cost plan forecasts.
