I attach the revised plans showing the relocation of the 6 bays (to a position around the bend) and an extension to the palace side facility. I hope this meets your approval, I think these plans look really good now. In addition, I propose that we lower the speed limit to 20mph between the palace roundabout and a point just east of the park gates, as shown on the attached word document. This will complement the new facility and provide extra comfort to those cyclists travelling eastbound. I need to get this safety audited and approved by cllrs without further delay. Please confirm that TFL will now release the 50k for install and I will be all systems go next week on getting this to implementation. The main engineer for this job is on leave end of august/first week of September, I will therefore be looking to start install mid Sept and will get approvals for a start date of **Sunday 13th September** (this will be an overnight closure to allow for removal of markings). Please confirm asap.
