Thank you for taking the time over recent months to help educate the Ola team regarding TfL expectations for companies seeking PHV Operator licensing in London.

I appreciate that it has been some time since Ola last spoke with you, so I wanted to drop you a line to provide an update.

Ola has spent considerable time ensuring that they are able to fully and comprehensively meet all the PHV Operator licensing requirements in London.

In addition though, the Ola team is now undertaking a substantial programme of work to develop standards that are significantly beyond those currently required by TfL, including around areas such as passenger safety and terms and conditions for driver-partners.

Would it be possible please to arrange a meeting for Ola to walk you and your team through these proposals, to hear your views and ensure a good understanding of these proposals, in particular where these proposals support TfL / Mayoral policy priorities, in advance of the PHV Operator licence application being submitted by Ola? This would be much appreciated.

I appreciate there are likely to be competing priorities in your respective diaries, but would w/c 11 or 18 June work, at a time suitable for your schedule?

Given his involvement in the past Ola dialogue with TfL, I copy Michael to this email for his information.
