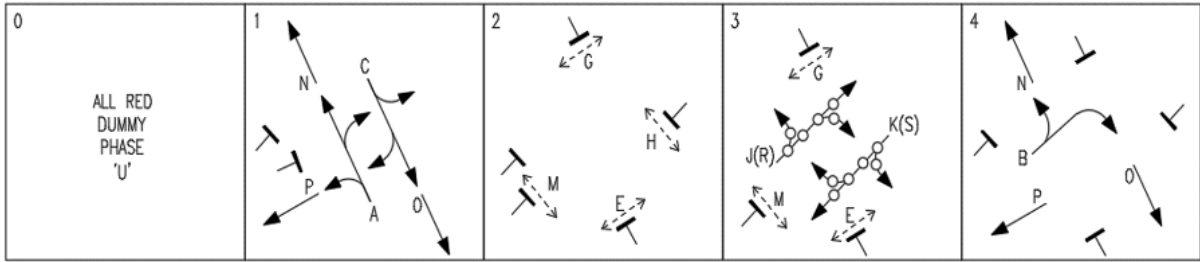

Hi All,

Just discussed the conflict with phase B & H. Firstly, the original timing sheet I created which has no intergreen between phases B & H or H & B, has been through a safety audit and has passed. A possible conflict between phases B-H was not flagged. Secondly, I've just asked an independent engineer and he agrees that there should be no intergreen between phase B & H. Phase B permits vehicles (cars) to turn left or right. If this was a full green however, then that would mean there should be an intergreen between these two phases.

So going forward this will remain without a conflict.

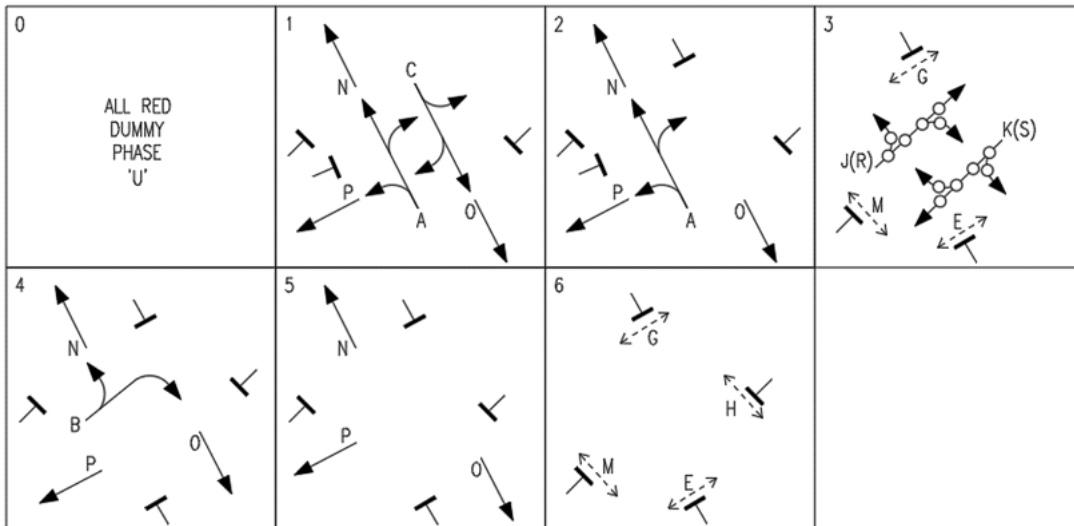

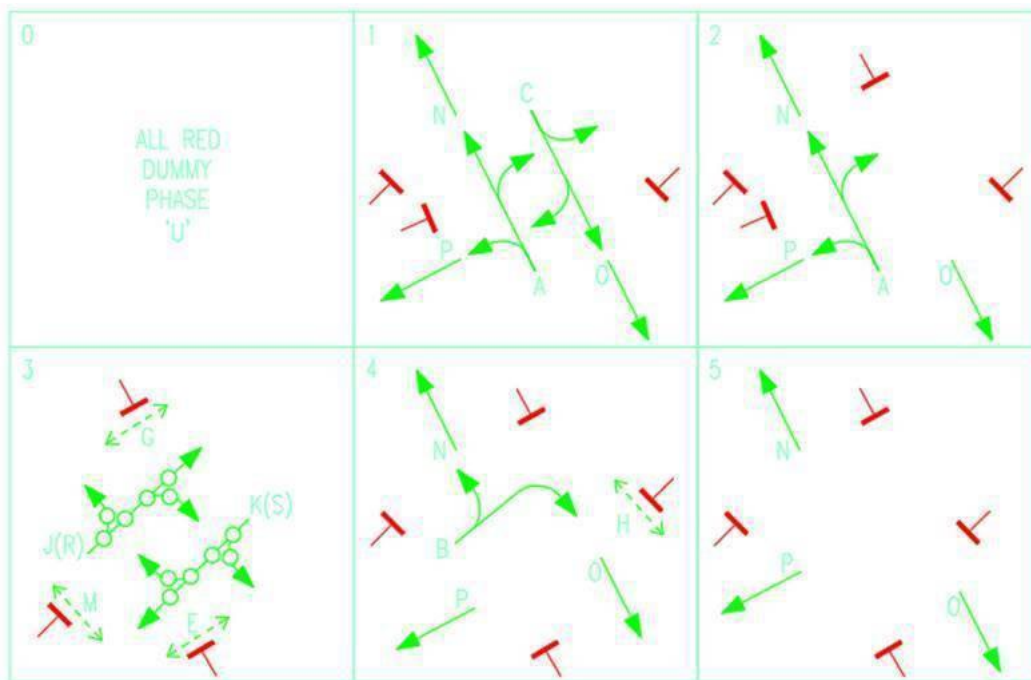
