Transport for London in exercise of the powers conferred by section 6 of the Road Traffic Regulation Act 1984^a, and of all other enabling powers, hereby makes the following Order—

1. Commencement and citation

This Order may be cited as The GLA Roads and GLA Side Roads (Royal Borough of Kensington and Chelsea) Red Route Consolidation Traffic Order 2008 A4 GLA Side Road (Exhibition Road) Variation Order 2012, and shall come into force on 13th August 2012.

2. Variations

The GLA Roads and GLA Side Roads (Royal Borough of Kensington and Chelsea) Red Route Consolidation Traffic Order 2008^b is varied by the following provisions of this Order.

- In Schedule 1 Side Road item 21. (in the vicinity of the A4) is substituted as follows: 21. EXHIBITION ROAD, the west side from the southern kerb-line of Cromwell Road (A4) to the north-western kerb-line of Thurloe Place.
- 2 In Schedule 1 Side Road item 22. (in the vicinity of the A4) is deleted.
- 3 In Schedule 1 Side Road item 23. (in the vicinity of the A4) is deleted.
- 4 In Schedule 1 Side Road item 24. (in the vicinity of the A4) is substituted as follows: 24. EXHIBITION ROAD, the east side from the southern kerb-line of Cromwell Gardens (A4) to the north-western kerbline of Thurloe Place.
- In Schedule 2A the following text is added after item 1. as follows:

 2. (in the vicinity of the (A4)) EXHIBITION ROAD, the west side area of highway parallel to and 10 metres east of the eastern wall of No.1 Cromwell Road, from a point 2 metres north of the common boundary of No. 1 Cromwell Road & No.14 Thurloe Place Mews northwards for a distance of 12 metres.

- In Schedule 4 Side Road item 21. (in the vicinity of the A4) is substituted as follows: 21. EXHIBITION ROAD, the west side from the southern kerb-line of Cromwell Road (A4) to the north-western kerb-line of Thurloe Place.
- 7 In Schedule 4 Side Road item 22. (in the vicinity of the A4) is deleted.
- 8 In Schedule 4 Side Road item 23. (in the vicinity of the A4) is deleted.
- In Schedule 4 Side Road item 24. (in the vicinity of the A4) is substituted as follows: 24. EXHIBITION ROAD, the east side from the southern kerb-line of Cromwell Gardens (A4) to the north-western kerb-line of Thurloe Place.
- 10 In Schedule 4 Side Road item 25. (in the vicinity of the A4) is deleted.
