



PUBLIC NOTICE:

HIGHWAYS ACT 1980 – SECTION 65

PROPOSED SHARED USE CYCLE TRACK THE A316 GREAT CHERTSEY ROAD, HOUNSLOW

Transport for London wishes to notify the local community that it proposes to convert lengths of footway adjacent to the A316 Great Chertsey Road in the London Borough of Hounslow to shared use cycle tracks. The works are programmed to start on 17th October 2011 and end on 25th November 2011.

The new cycle track(s) will be on the northern and southern footway of Great Chertsey Road from A312 Apex Corner to B358 Hospital Bridge Road

- Shared use cycle tracks will be for cyclists and pedestrians where both will share the full width of the new cycle track, with each having equal rights over it. Signs and road markings will be used to mark the start and finish of the cycle track, and will make clear where the footway has been converted to a shared use cycle track.
