THE A202 GLA ROADS (VAUXHALL BRIDGE, CITY OF WESTMINSTER AND LONDON BOROUGH OF LAMBETH) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2020

Made 31st July 2020

Coming into force 2nd August 2020

Transport for London in exercise of the powers conferred by section 14(1) of the Road Traffic Regulation Act 1984^a, and of all other enabling powers, hereby makes the following Order:-

- This Order may be cited as The A202 GLA Roads (Vauxhall Bridge, City of Westminster and London Borough of Lambeth) (Temporary Prohibition of Traffic) Order 2020, and shall come into force on the 2nd August 2020.
- 2. This Order is made because Transport for London is satisfied that traffic in the City of Westminster and the London Borough of Lambeth should be prohibited from making certain movements on sections of A202 Vauxhall Bridge and Bridgefoot because works are being executed.
- **3.** From 8:00 PM on 2nd August 2020 until 11:59 PM on 26th March 2021 or when those works have been completed, whichever is the sooner, subject to the provisions of article 4 below, no person shall cause or permit any vehicle to enter or proceed on Vauxhall Bridge/ Bridgefoot between their junctions with Millbank/ Grosvenor Road and Albert Embankment/ Wandsworth Road.

The Order will also:

- (1) suspend the northwest-bound and southeast-bound bus lanes on Vauxhall Bridge/ Bridgefoot between their junctions with Millbank/ Grosvenor Road and Albert Embankment/ Wandsworth Road;
- (2) suspend the cycle track on Vauxhall Bridge/ Bridgefoot between its junctions with Millbank/ Grosvenor Road and Albert Embankment/ Wandsworth Road;

- (3) suspend the north-eastern and south-western footways of Vauxhall Bridge/ Bridgefoot between their junctions with Millbank/ Grosvenor Road and Albert Embankment/ Wandsworth Road.
- **4.** (1) The provisions of article 3 above shall apply only during such times and to such extent as may from time to time be indicated by traffic signs.
 - (2) The provisions specified in article 3 above shall not apply in respect of:
 - (i) any vehicle being used for the purposes of those works and vehicles associated with the cleaning of the carriageway;
 - (ii) any vehicle on any occasion when it is being used for fire brigade, ambulance or police purposes if the observance of those provisions would hinder the use of the vehicle;
 - (iii) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
- **5.** At such times as the prohibitions are in force alternative routes will be indicated by traffic signs.
