# Track, signalling and equipment alterations

## Platform temperature and humidity monitoring

From Monday 31 August 2020 for two weeks, staff from TfL Vehicle Engineering – Technical Services will be on all sub-surface line platforms to download information from “Tinytag” loggers using handheld tablet PC’s. This work will be undertaken during traffic hours.



Please note that under LU Rule Book concession CR0840 I, these staff are not required to book in as visitors at each station due to the brevity of the task. The time per logger is expected to be a few minutes, so no contact is required be made with the station staff.

## Circle and Hammersmith & City, District and Metropolitan lines

### Start of Communication Based Train Control (CBTC) operation of Battery locomotives type 'A' between Hammersmith (C&H) – Finchley Road / Paddington (Circle) / Euston Square

The Four Lines Modernisation project has commissioned software to enable the operation on Battery Locomotive type 'A' Engineering locomotives under CBTC control between Hammersmith – Finchley Road / Paddington (Circle) / Euston Square.

From start of traffic on Monday 31 August 2020, Battery Locomotive type 'A' will be permitted for use in these areas under CBTC control and new four foot 'E' stopping diamonds will be brought into use for Engineers Vehicle operators only.

At Hammersmith platform 1, any Engineers train consist greater than 95m will result in the east end of the formation being positioned over 21A points.

'E' Stopping Diamonds will be positioned in the four foot (unless otherwise stated) at the following locations:

## Temporary and emergency speed restrictions

New Temporary Speed Restrictions (TSRs) will be published in the Traffic Circular for two weeks only.

Any removal of a speed restriction will be advertised for two weeks running up to its removal.

Emergency speed restrictions which are in force for longer than a week will be treated as TSRs.

Train operations managers must ensure that temporary and emergency speed restrictions are placed in the late notice case and the permanent notice case as appropriate.

Service control managers are responsible for ensuring information concerning speed restrictions is maintained throughout service control locations as appropriate.

## LU bridge, underbridge and structure restrictions

Information on structure restrictions can be found on the Rule Book team SharePoint site. <https://transportforlondon.sharepoint.com/sites/TMSRuleBook> click on Traffic Circular and follow the link for bridge and structure restrictions. All new entries are published in the Traffic Circular for publication and on the SharePoint site until withdrawn. Notice of withdrawn entries will also be published in the Traffic Circular for one issue.

## Restrictions on underbridges

Various trains are restricted over the following bridges as shown in the table below:

Note – restrictions only apply to the Piccadilly line and not the District line which may run over the same bridge – it is an issue associated with the longitudinal timbers supporting the track.

**Loading restrictions on structures other than underbridges**

Passenger loading only refers to a load not in excess of ½ tonne (500 kg) on an area 1m x 1m<sup>2</sup>, including for example such items as cable drums, large plant, and storage of construction materials.

### **Temporary amendments to Piccadilly line Timetable Notice No. 222/20, Mondays to Fridays, commencing Monday 7 September until Friday 2 October**

One train will not be available for the Piccadilly line peak service during this period for conversion to Rail Adhesion Trains in preparation for Leaffall. In consequence, temporary amendments apply to the Mondays to Fridays service in Piccadilly line Timetable Notice No. 222/20.

- Passengers travelling between stations Tower Hill/Aldgate/Aldgate East – Bromley-by-Bow must be advised to use rail replacement bus Service DL-6.
- Passengers requiring to connect between rail replacement bus Service DL-6 and the eastern section of the District line must be advised to use the Jubilee line between Canning Town and West Ham.
- Passengers travelling between central London and stations West Ham – Upminster must be advised to use c2c train services to/from Fenchurch Street, or Jubilee line or Docklands Light Railway services via West Ham.  
**Note:** There will be no c2c train service between Fenchurch Street and Upminster before 10.00 on Sunday and Monday, 30th and 31st August.
- Passengers travelling between central London and Mile End must be advised to use the Central line.
- Passengers must be advised to use alternative LU train services or local bus services, changing where necessary. LU tickets and passes will be accepted on existing local bus routes.

**Additional passenger journey time:** 40 minutes.

**Late night passengers:** Must be advised to commence their journeys 40 minutes earlier than normal to maintain last train connections.

The amendment clarifies that in cases of multiple signals failing, or track circuit failure, the signaller will advise the train operator of the exact number of block marker boards they can pass without stopping to reach the next colour light signal.

This amendment incorporates the content of written notice LU-WN-01624 published in December 2019 and, as such, this written notice has been withdrawn with immediate effect.
