THE GLA ROADS AND GLA SIDE ROADS (CITY OF WESTMINSTER, LONDON BOROUGH OF CAMDEN AND ROYAL BOROUGH OF KENSINGTON AND CHELSEA) (20 MPH SPEED LIMIT) ORDER 2022

Coming into force

9th April 2022

Transport for London in exercise of the powers conferred by sections 83 and 84 of the Road Traffic Regulation Act 1984^a, and of all other enabling powers, hereby makes the following Order—

1. This Order may be cited as The GLA Roads and GLA Side Roads (City of Westminster, London Borough of Camden and Royal Borough of Kensington and Chelsea) (20 MPH Speed Limit) Order 2022 and shall come into force on the 9th April 2022.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 20 miles per hour on any of the lengths of road specified in Schedule 1 to this Order.
3. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on any of the lengths of road specified in Schedule 2 to this Order.
4. The provisions specified in articles 2 and 3 above shall not apply in respect of:
 - (1) any vehicle on any occasion when it is being used for fire brigade, ambulance or police purposes if the observance of those provisions would hinder the use of the vehicle for the purpose for which it is being used on that occasion;
 - (2) anything done with the permission of or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. No person shall cause or permit any vehicle to exceed the maximum speed limit unless otherwise indicated by traffic signs varying the speed limit.
