Appeal by way of complaint against a decision to refuse an application for a London Public Hire Vehicle operator's licence made on 03/10/2020 by TfL - Taxi and Private Hire.

In accordance with Section 17(4) of The Private Hire Vehicles (London) Act 1998.

It is ordered that 1. Subject to the Court being satisfied as to the matter in paragraph 2 below: a. This appeal by Ola against the decision by TfL made on 3 October 2020 to refuse the renewal of Ola's Private Hire Vehicle Operator's Licence licence under section 25 of Private Hire Vehicles London Act 1998. b. The Court is satisified that Ola is now a fit and proper person to hold a licence. c.The Court shall grant Ola an operator's licence for a period of 15 months from the commencement date referred to in paragraph 2 below, subject to the conditions annexed to this order the dates in which may require amendment to give effect to the conditions in light of the commencement date 2. Paragraph 1 above is subject to the Court being satisfied that Ola's terms and conditions of business are compliant with the requirements under the Act for the operator to contract as principal as set out in R o/a/o United Trade Actuon Group -v- Transport for London and Transopco UK Ltd 2021 EWHC 3290 Admin then part 8 Judgement. Upon the Court being satisfied of such fact, the licence will come into effect the commencement date. 3. In order to assist the Court in determing the issue set out a paragraph 2 above. Ola and TfL with liaise with expedition with a view to satisfying TfL that Ola is in compliance with the Part 8 Judgment. The parties will update the Court as soon as is reasonably possible. In the event that Tfl is not, within a reasonable period of time, so satisfied, TfL shall invite the Court to list a hearing in order to determine the appeal. 4. Paragraph 2 is subject to the Part 8 Judgement not being stayed pending appeal or any further inconsistent decision from the Court of Appeal or Supreme Court to a different effect. 5. The Appellant shall pay the Respondent's costs of £306.790 within 28 days.
