Some of the changes were planned to occur today. There is then going to be short break (to align with traffic order dates) with some further changes at the end of Jan. Let me see which ones were today and which were the end of the month. These changes are to resolve some of the immediate operational issues with the remaining changes still be enforced through temporary traffic orders.

In terms of more substantial changes to the proposals, such as those you are seeking at Rowfont Road, these will be brought forward later this year as part of an experimental traffic order. I think that it would also be useful to meet again to look at the experimental changes.
