# THE GLA SIDE ROADS (CITY OF LONDON) DESIGNATION ORDER 2007

Made 23/4/07
Coming into force 23/4/07

The Mayor of London considers it expedient that certain roads in the City of London should become or cease to be GLA Side Roads. Therefore, the Greater London Authority, in exercise of the powers conferred by section 124B(2) of the Road Traffic Regulation Act 1984<sup>a</sup> and of all other enabling powers, and with the consent of the Council of the City of London, hereby makes the following Order:

#### 1. Citation and Commencement

This Order may be cited as the GLA Side Roads (City of London) Designation Order 2007 and shall come into force on 23/4/07

#### 2. Interpretation

In this Order any reference to "road" includes a length of road.

#### 3. Revocation

The GLA Side Roads (City of London) Designation Order 2000<sup>b</sup> is hereby revoked.

#### 4. Direction

- (1) The Greater London Authority hereby directs that the roads defined in the schedule to this Order shall become GLA side roads.
- (2) The date on which the roads referred to in paragraph 3 shall be revoked and the date that the roads defined in the schedule to this Order shall become GLA Side Roads shall be the coming into force date cited above.
