



Pier Use Charges Effective from 1 October 2022

From 1 October 2022 different charges will apply to different LRS piers. Westminster, Embankment, Tower, Greenwich and Festival piers will be charged at a different rate to Millbank, Blackfriars and Bankside piers.

Westminster, Tower, Embankment, Greenwich and Festival

Point-to-point and Circular services (regular open public service vessels):

The charges set out below are chargeable for each act of embarkation, disembarkation or en-route call: **£26.41**

Charter Services (contract, hired or leased for exclusive or private use):

These charges apply to each act of embarkation, disembarkation or en-route call.

Peak Surcharges

Charters on Halloween (or nearest Friday and Saturday) will incur an additional surcharge of **£100** per charter. New Year's Eve charters will incur an additional surcharge of **£200** per charter.

Sailing Barges:

Charge per embarkation and/or disembarkation at an LRS pier: **£100.00**

Water Taxi Services:

Charge per embarkation and/or disembarkation at an LRS pier: **£26.20**

Privately Owned Vessels:

All private vessels must comply with LRS safety requirements. Charge per embarkation and/or disembarkation at an LRS pier: **£100**

Standing Alongside:

Charges per 30 minutes or part thereof:

Up to 48m **£68.12**
Over 48m **£136.24**

All vessels: **£31.44 + VAT**, or Annual Water Contract: **£628.80+ VAT**

Sewage Disposal:

In addition to any mooring fees (see above), charge for the use of facilities: **£47.16 + VAT**

Electricity Supply:

Fixed charge for all non-commercial users: **£31.44 + VAT**

Exclusive Use of berths, passenger areas or piers for private events:

All requests for exclusive use of berths should be made in writing to the LRS Piers Manager, who will provide a quote for your requirements. Any exclusive use of the pier will need to be licensed, with appropriate paperwork completed prior to the event. A minimum of **six weeks'** notice is required for all exclusive pier use events.

Unauthorised use of pier or pier facilities:

Any vessel or operator identified using any LRS pier or pier facilities without preauthorisation or confirmed booking will, in addition to the relevant mooring fee, be subject to an unauthorised use charge of **£628.80 + VAT**

Millbank, Blackfriars and Bankside

The charges set out below are chargeable for each act of embarkation, disembarkation or en-route call: **£18.86**

Charter Services (contract, hired or leased for exclusive or private use):

These charges apply to each act of embarkation, disembarkation or en-route call.
