Thanks for clarifying. I'll send on the TMO to the police for them to carry out an assessment. I've asked [REDACTED] and [REDACTED] of Gov Relations if they can pinpoint the stretch that has speeding, which from looking on google, is likely the Wandsworth side like you state.

Our current position and lines on speeding cameras is as follows:

In our Vision Zero Action Plan, we committed to expanding London's safety camera network as part of efforts to reduce speed and speed-related collisions in the capital. This is still our intention but we are not in a position to do so now. We are undertaking the essential preparatory work for this and ensuring we have all the necessary elements in place before rolling out new camera sites. This includes implementation of offence processing technology, recruitment of enforcement staff, and exploring new camera technology to ensure that we are investing in the best and most cost-effective systems for the future. We are also in the early stages of a contract relet for our two main safety camera providers with contracts due to expire in 2024. Once we are in a position to expand the network, we will need to redo the detailed analysis to prioritise locations for safety cameras, using a methodology that was developed in consultation with the boroughs and London Councils prior to the pandemic. We need to do this to take account of any changes in travel projections and road user behaviour, as well as the significant changes made to road layouts during the pandemic.

As we're not able to commit to a speed camera at present, I will be putting this forward for assessment and forwarding through the political concerns about it so the police are aware.

Hello [REDACTED]

I'm not sure of the extent of each borough's control over each arm of Croxted Road but the attached 20mph speed limit TMO was made by Southwark and covers the whole of Croxted Road, and from the preamble it is clear that this was done with Lambeth's consent. The exception to the 20mph speed limit is where TfL is the traffic authority for the return off the S. Circular. We are expecting to incorporate this section in September when the S.Circular will be made 20mph in this area.

I don't think the real area of concern is our section as it only covers a small amount of Croxted Road but I did recently receive a request for a speed camera in our section on the northern arm. It would be good to know in general what our latest position is with speed/safety cameras as I know we changed our approach for various reasons recently (move over to digital, processing capacity, pandemic etc.). I think we need to know that before we meet with anybody.

Subject: Speeding on Croxted Road and a Speed Camera

Dear All

My apologies for cc'ing everyone in but as Lambeth Highways, the Metropolitan Police and TFL everyone has a regulatory stake in Croxted Road traffic management.

The problem of speeding on the road is really well documented and we are in the position where there have been several serious accidents. Most recently there was a collision on the road between Pymers Mead and Turney Road, where Lambeth are the highways authority. On the stretch of road where Southwark are the authority there are speed cameras.

The recent speedwatch, run by the community with support of PCSO Stanlick has shown the extent of the problem. There is a real danger of fatality and in the last year there have been at least two hospitalisations that we know of as a result of speeding accidents.

Either myself or Cllr Cavanagh have talked to you about a speedcamera and in the absence of a clearly established way forward for Croxted, I would like to suggest a meeting to work out how one could be placed on the section of road that is Lambeth's responsibility. Cllr Chowdhury as cabinet member has in principle agreed to this and gave a formal written answer to full council last year to this effect.

If any availability could be offered I would be really happy to facilitate this asap so we can get a plan in place to deliver a camera for this very dangerous stretch of road.
