There have now been another couple of serious incidents, occurring on 27th September and 10th October, with regards to cars aquaplaning on the stretch of road just in front of the entrance to our petrol station, please see below the updated list of incidents in chronological order.

Please find details below:

• Incident Date: 03.12.2019

A BMW was driving at speed along the A20 and then the driver lost control. The car came onto the forecourt and impacted the hooped bollard which protects fuel pumps 1 & 2. The vehicle then spun around and hit the bollard at the back of pumps 3 & 4. There were four occupants of the car and the fire brigade and ambulance service attended the scene.

The cost of the damage to our property was £1500

Incident Date: 15.08.2020

A vehicle was travelling along the outside lane of the A20 when it hit surface water, aquaplaned and spun around. The vehicle then proceeded onto the forecourt hitting the bollard in front of pump 1&2. It then spun around hitting a car parked at pump 3. The petrol pump was impacted and emergency services attended the site.

The cost of the damage to our property was £10,000.

• Incident Date: 13.02.2022

A vehicle lost control on the duel carriageway during heavy rain, spun around impacting a van driving onto the forecourt. The car then impacted a hooped bollard in front of the pump and launched into the stanchion. Emergency services attended the site.

The cost of the damage to our property is estimated £100,000.

• Incident Date: 10.10.22

At 8:15 am a white Mercedes car skidded on the A20 into the entrance of our forecourt and collided into a car filling up at pump 1 . The site was closed temporarily whilst emergency services attended.

Obviously, the situation needs urgent attention, especially considering the further recent incidents.

I am seriously concerned that it is only a matter of time before we have yet another serious incident here. Please can you pass the details attached to someone in your organisation that can arrange urgent alterations to this location and work with us to ensure cars cannot crash like this across our forecourt.

I am of Rontec Roadside Retail, we operate 265 petrol forecourts across England and Wales.

I have serious concerns around a stretch of dual carriageway on the A20 in Kent. Despite 3 serious accidents in the last 3 years there seems to be no plan or movement on making the stretch of road safer. All 3 accidents have involved vehicles aquaplaning at speed across the carriageway on pontoon our forecourt. Thankfully no one has been seriously injured, however I fear it is only a matter of time before another accident and a possible serious injury.

I have attached details of the 3 incidents and some photos to show just how lucky those involved have been. Repairs following the latest incident will cost in excess of £100,000 because of the serious structural damage to the sites infrastructure.

I am sure there are some sort of traffic calming/speed reduction measures that can be taken, prior to any proper schemes being completed.

Can you please pass this onto the relevant colleague within your organisation, that has the authority to move on this quickly and decisively.
